### **About the Exhibition**

## Economic scenario of South Korea

South Korea offers development experience that inspires many developing countries in sustainable development, provision of infrastructure and better services to improve the lives of the people, and transition to a dynamic knowledge economy. South Korea's economy has had a sharp albeit uneven bounce from the Covid-19 slump in 2020 as exports expanded at their fastest annual pace in 11 years while the consumption recovery has been patchy due to social distancing curbs.

## Trade in Engineering sectors

India's engineering exports to South Korea in 2021-22 recorded US\$ 3.08 billion, registering a growth of 58% over 2020-21. India's major engineering exports to South Korea include Aluminium and products made of Aluminium, Iron and steel, Lead and products made of lead, Auto Components/Parts, Electric Machinery and Equipment, Zinc and products made of zinc, Copper and products made of copper, Industrial Machinery for dairy, agriculture, food processing, textiles, paper, chemicals, etc. India's exports of Foundry and Forging products during 2021-22 stood at US\$ 38.2 million, registering a growth of almost 9% compared to export during 2020-21.


## Opportunity for Indian Engineering Industry

The Indian Engineering sector has witnessed a remarkable growth over the last few years driven by increased investments in infrastructure and industrial production. India overtook US to become the second largest casting producer globally. The Indian foundry industry is producing around 12 million MT of various grades of castings as per international standards. The Indian foundry industry has a turnover of around US\$ 19 billion with exports amounting to US\$ 3.1 billion. Annual output of the Indian forging industry stood at 20 lakh MT in FY 21 from around 400 forging units countrywide. Thus India has tremendous potential in catering to the needs of the Korean market for foundry and forgings.

Moreover post pandemic the revival in global and Korean economy is expected to boost India's engineering exports further. India having a FTA with the Korea will definitely have an added advantage in its exports to Korea over its other counterparts.

## COVID-19 Protocol & Travel Advisory

Republic of Korea has allowed international travel (in-bound and outbound) from April 1, 2022 with some sort of Covid restrictions. However from June 1, 2022, all travel restrictions and Covid curbs are totally lifted for in South Korea.

All travelers must provide a Negative COVID-19 PCR Test Result Certificate from a PCR test taken within 48 hours prior to departure date irrespective of their vaccination status. Fully vaccinated individuals (WHO approved emergency COVID-19 vaccine) are exempt from quarantine. These individuals must have been fully vaccinated for at least 14 days, but within 180 days, or have received a booster shot (third dosage). Non-vaccinated or individuals who have not completed three doses have to undergo a mandatory quarantine of 7 days. From June 8, 2022, unvaccinated travelers are also allowed to travel to Korea and not required to quarantine but subject to submit a negative PCR test.

Since limited space is available, selection of participation will be done strictly on first-come, first-served basis.

## Benefit to the member-exporters

EEPC India is proposing to organise this event under the International Cooperation (IC) Scheme of MSME Ministry, Government of India.

## The eligible MSME Units will receive following Assistance:

### 1. Reimbursement of Stall Charges

Amount received from the Department of MSME against this head will be reimbursed to the participants subject to a ceiling of Rs. 2,80,000.

### 2. Reimbursement of Airfare

100% of the economy class airfare subject to a maximum of Rs.1.50 lakh or actual fare paid, whichever is lower (for one per MSME unit) subject to following condition:

- Journey/Stay should be within a span of 30 days including the period of event
- The participants are required to travel by the shortest route.

#### Document required for Air-fare reimbursement:

- Original boarding pass (in case of multiple Boarding passes, Provision of Original Boarding pass of destination city / host city of the event under consideration is must). In case of non-availability of original boarding pass for reasons to be conveyed in writing, a certificate from the airlines stating that the journey has been undertaken will be acceptable.
- Copy of e-ticket / ticket complete in all respect with fare information on e-ticket for air travel.

### 3. Freight Support

Each participating company will get freight support up to Rs 50,000 per MSME unit. This will be subject to submission of relevant documents as per the MSME Ministry guidelines.

- Copy of TAN number
- Copy of valid Udyam Registration Certificate of the participating unit.

## Cancellation of participation


Please note that no request for cancellation and / or refund including of advances, if any and / or adjustment thereof shall be accepted for any reason whatsoever. Once the application form and / or advance / part payments are accepted by EEPC India the participant remains liable to pay in entirety the amounts due from them on account of the event.

In case members are not able to travel due to travel restrictions/advisory by Government of India or South Korea then the amount paid will be adjusted toward the participation in the next edition.

Note: Regarding goods taken out of India for exhibition or on consignment basis for export promotion, participants may refer to Circular No. 108/27/2019-GST dated 18.07.2019 of the Central Board of Indirect Taxes and Customs (CBIC) which is the statute in the matter.

## Force Majeure:

If a Force Majeure Event like war, act of God, natural calamities, governmental directives, civil commotion, epidemic, pandemic, etc. or alike events occurs inasmuch as that the fair authorities/ organizers consider that it is illegal, impossible, inadvisable or impracticable for the physical, onsite and in-person (i.e. 'live') elements of the Event to be staged, then in such situation and/ or circumstances the decision of the fair authorities shall be final and binding upon EEPC India and all its co-exhibitors/ participants. In such situation and/ or circumstances, if the fair authorities, organizers or the vendors appointed for providing diverse services related to the Event in question does not refund the monies paid by EEPC India and/ or does not otherwise absolve EEPC India from its contractual obligations then in such case the Co-exhibitors / participants remain liable to pay to EEPC India the contracted participation charge in full and shall not receive any refund from EEPC India of the amounts paid by the co-exhibitors/ participants. Further, if the fair authorities, organizers or the vendors, so appointed for the Event binds or rolls over EEPC India's participation in the future editions of the same Event in question, then automatically the participation of the co-exhibitor/ participant shall also be carried forward to such future editions of the Event and the amounts paid by them shall be given a credit for the successive edition. However, if there is any increment in the participation fees fixed by the fair authorities, organizers or in any other charges, budgets, etc. then such increased amount has to be paid by the co-exhibitor/ participant without any demur based on the space and booth booked by the co-exhibitor/ participant. In any event, a co-exhibitor/ participant cannot decrease the space or the booth size booked by them for the originally scheduled Event.
